## **CRVS++ Model in Bangladesh**



Bangladesh wants to establish a robust and effective CRVS process based on Unique ID (UID) system and intends to link it with service delivery processes. Along with the six basic components (*birth, death, marriage, divorce, adoption and cause of death*) enrolment in the education system, and migration (in and out) has also been added as major components of CRVS in Bangladesh.

Links has been established with Bangladesh Bureau of Statistics (for generating Vital Statistics) and other service delivery processes especially with the Social Protection Programs. An Integrated Service Delivery Platform is being developed as a part of CRVS implementation plan.

# **CRVS coordination mechanism in Bangladesh**

CRVS Related Steering Committee headed by the Cabinet Secretary. 18 secretaries and head of agencies are members of the committee.

#### **Objectives of the mechanism**

- Coordinating activities of different ministries/divisions in order to ensure overall development of the Civil Registration and Vital Statistics (CRVS) system;
- Providing necessary suggestions and guidance to relevant agencies in order to implement CRVS activities;
- Evaluation and analysis of CRVS related strategies and workplans; and



Other CRVS related necessary issues.





# **CRVS coordination mechanism in Bangladesh Contd.**

- CRVS Coordination mechanisms works across agencies (horizontal) through regular meetings, signing of MoUs etc among different agencies of GOVT and partners.
- There is a CRVS Implementation Committee.
- There are several sub-committees based on tasks and themes – legal review committee, technical committee etc

#### **Broad Achievements**

- Introduction of the 10 digit UID (NID has been changed to the UID).
- Establishment of the CRVS Secretariat.
- Introduction of MCCoD and VA for cause of death determination.
- Engagement of the health staffs for birth and death notification process.

#### **Achievements in Piloting area**


- Introduced MCCoD first time in Bangladesh with approval of MoHFW;
- National mortality technical working group formed;
- Hospital mortality technical working group formed;
- Steps taken to incorporate CoD in medical curriculum;
- Steps taken to introduce MCCoD in all health facilities;
- Determined approximate CoD of 10000 rural death using verbal autopsy;
- Determined CoD of 11000 facilities death using MCCoD introduced by WHO forall countries in 1967;
- 6000 physicians trained in MCCoD and 600 health staff in VA.

Chart : Year wise Comparision - % of Birth Registration with regards to Estimated Births [Kaliganj]








#### **Achievement in Birth Registration**

Chart: % of Birth Registration by Different Time Slots - Before and After the Intervention [Kaliganj]








#### **Achievement in Death Registration**

#### Chart : Completeness of Death Registration (within 45 days) before and after the intervention [Kaliganj]









#### **Achievement in Death Registration**
