Official language: **Mongolian**

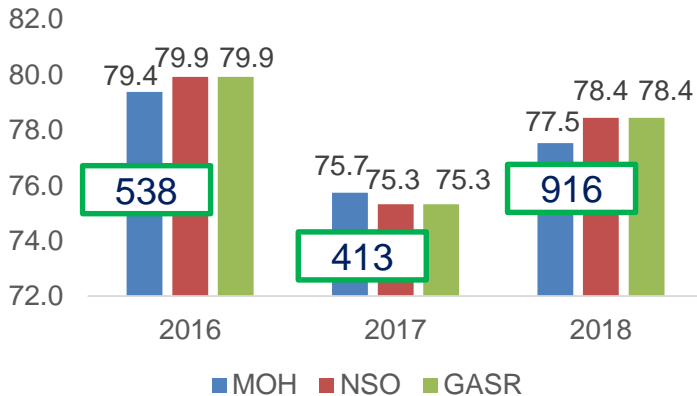

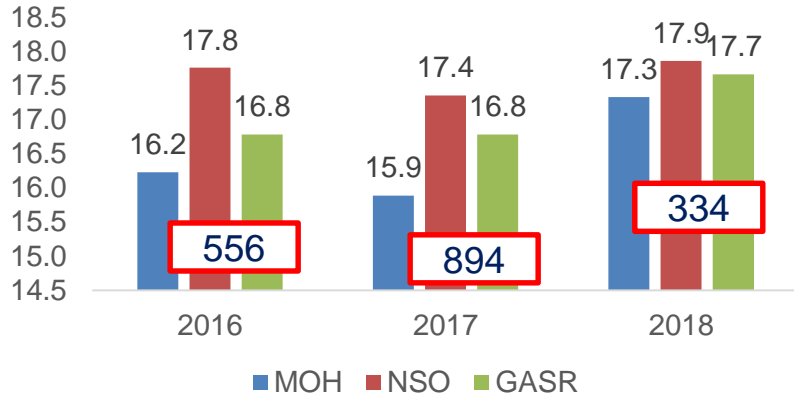
THE GAP BETWEEN REGISTERED BIRTH AND DEATH

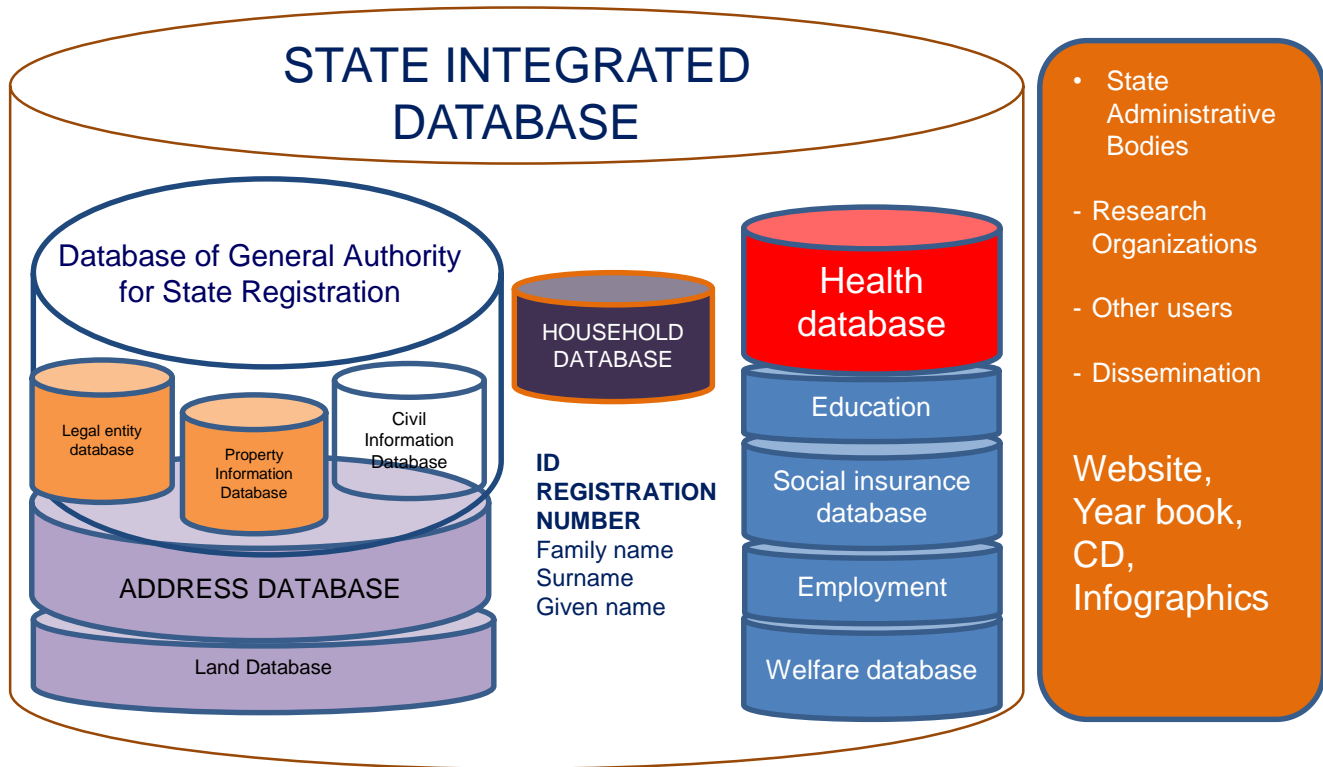

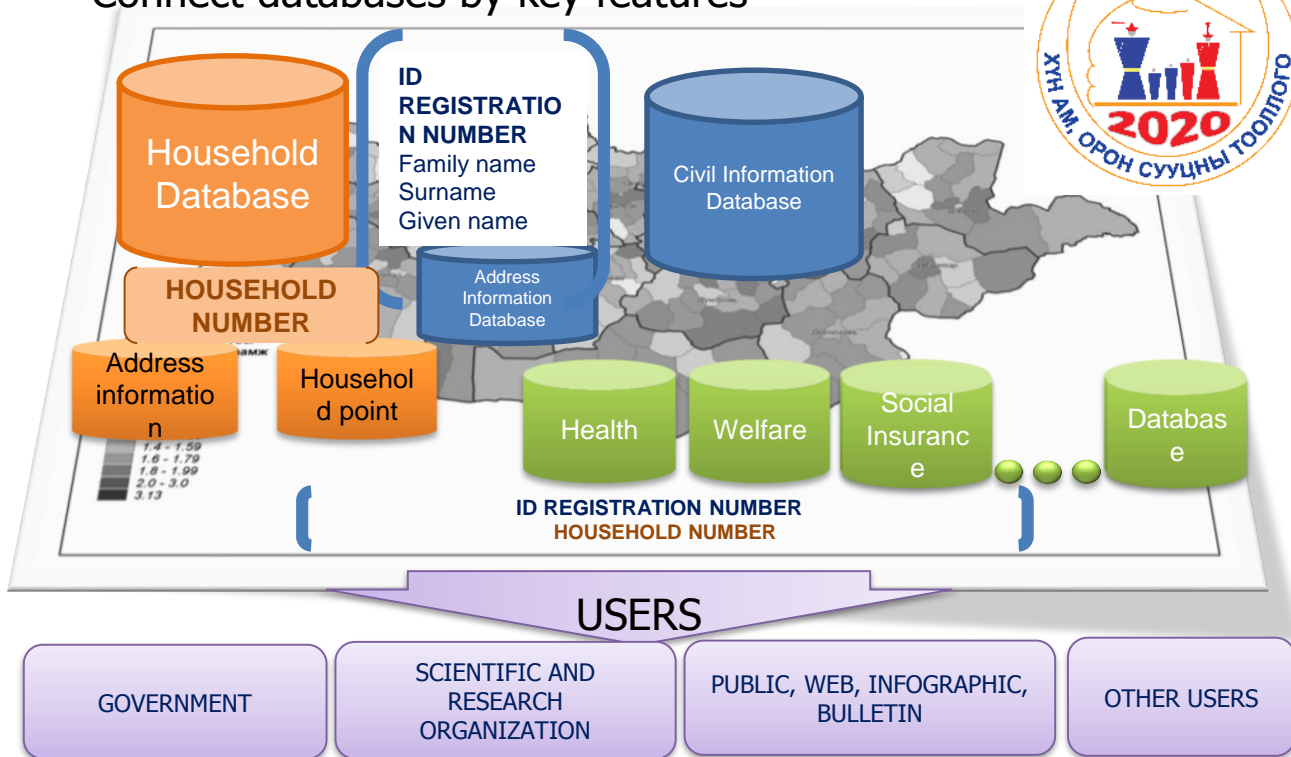
1. Adopted by Government of Mongolia in 2018

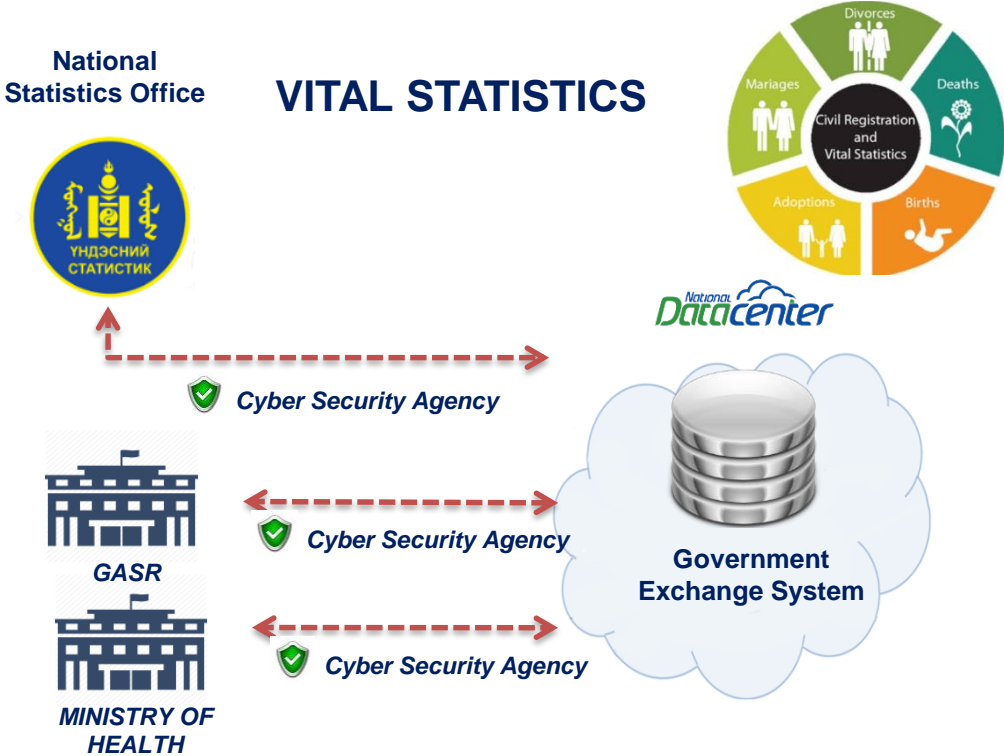

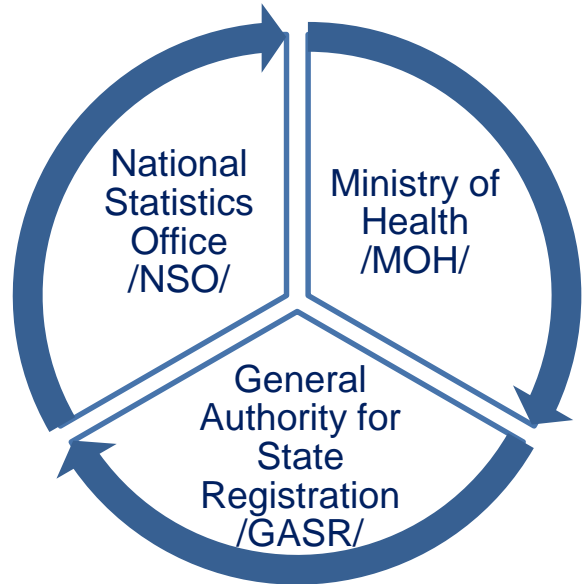

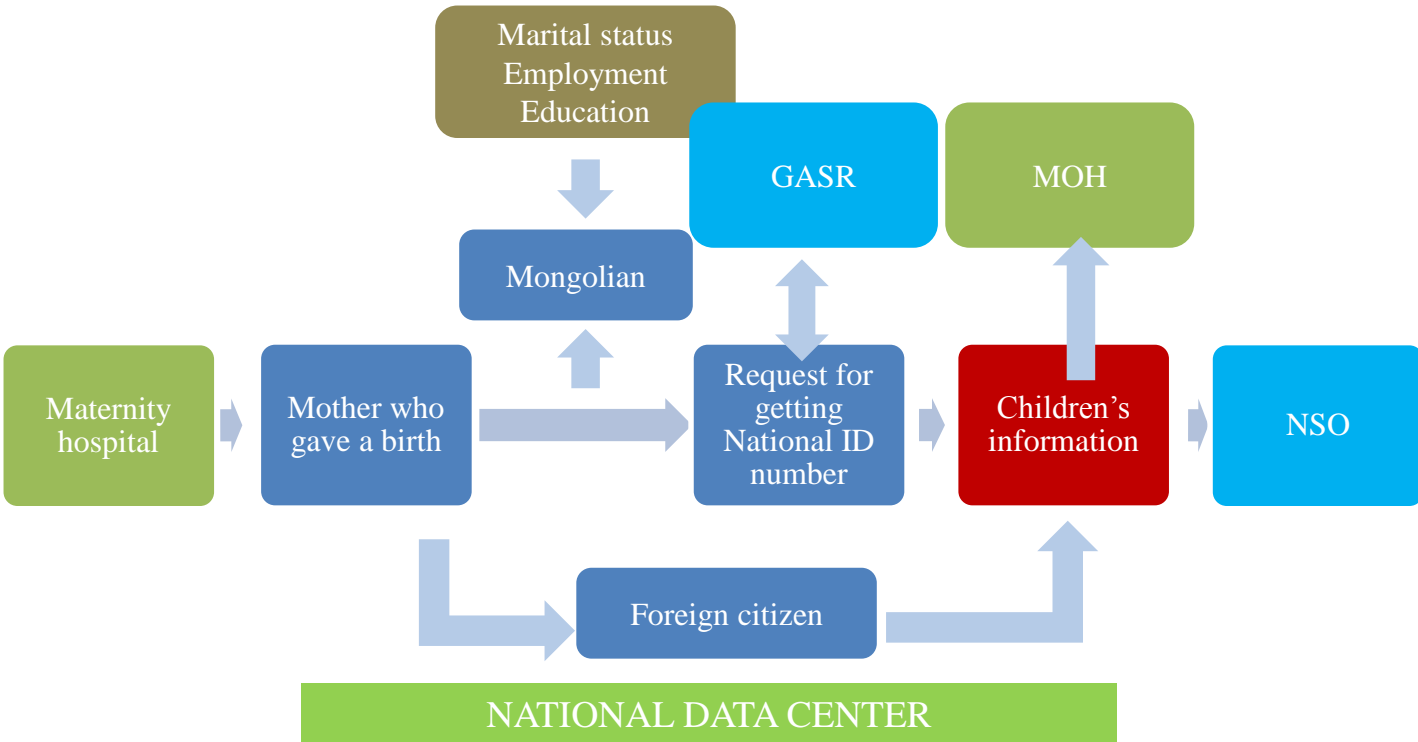

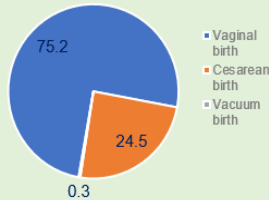

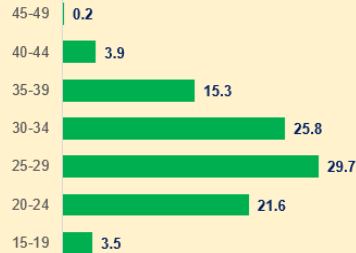

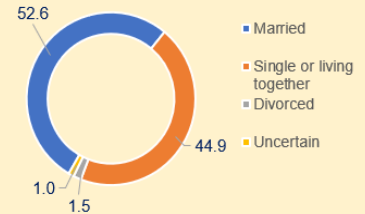

Marital status by percentage



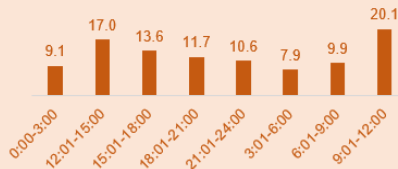

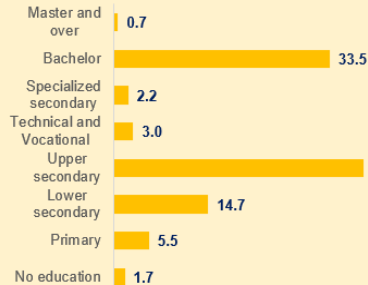

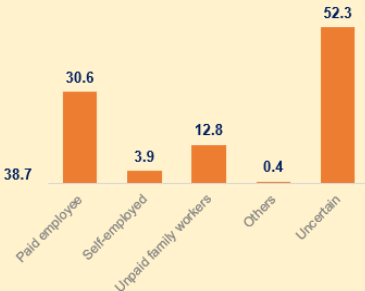
Newborn by hour, percentage



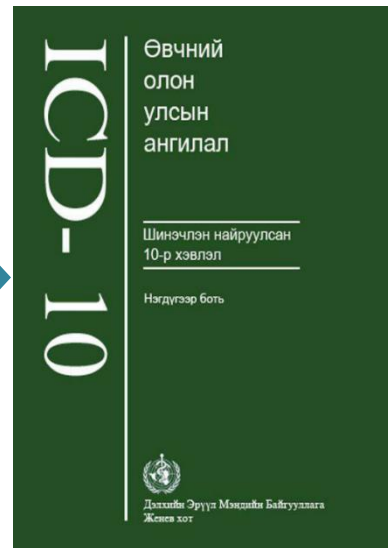
Education level by percentage



Employment status by percentage

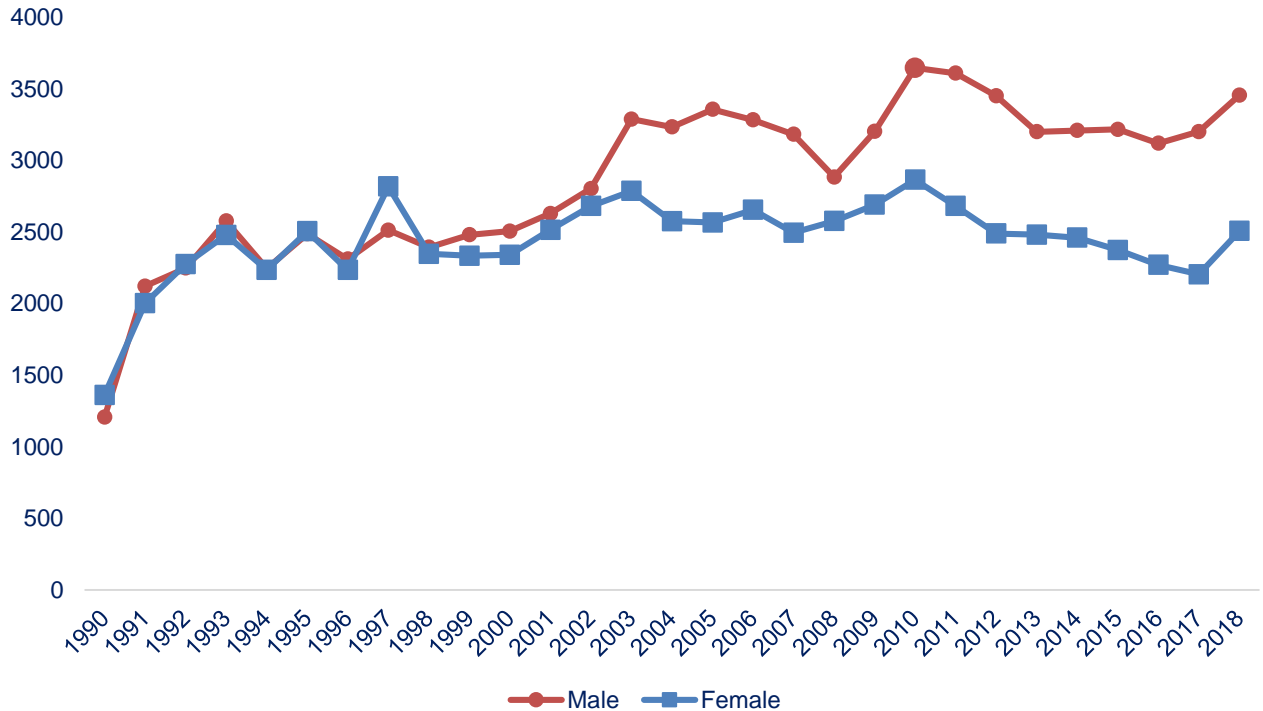

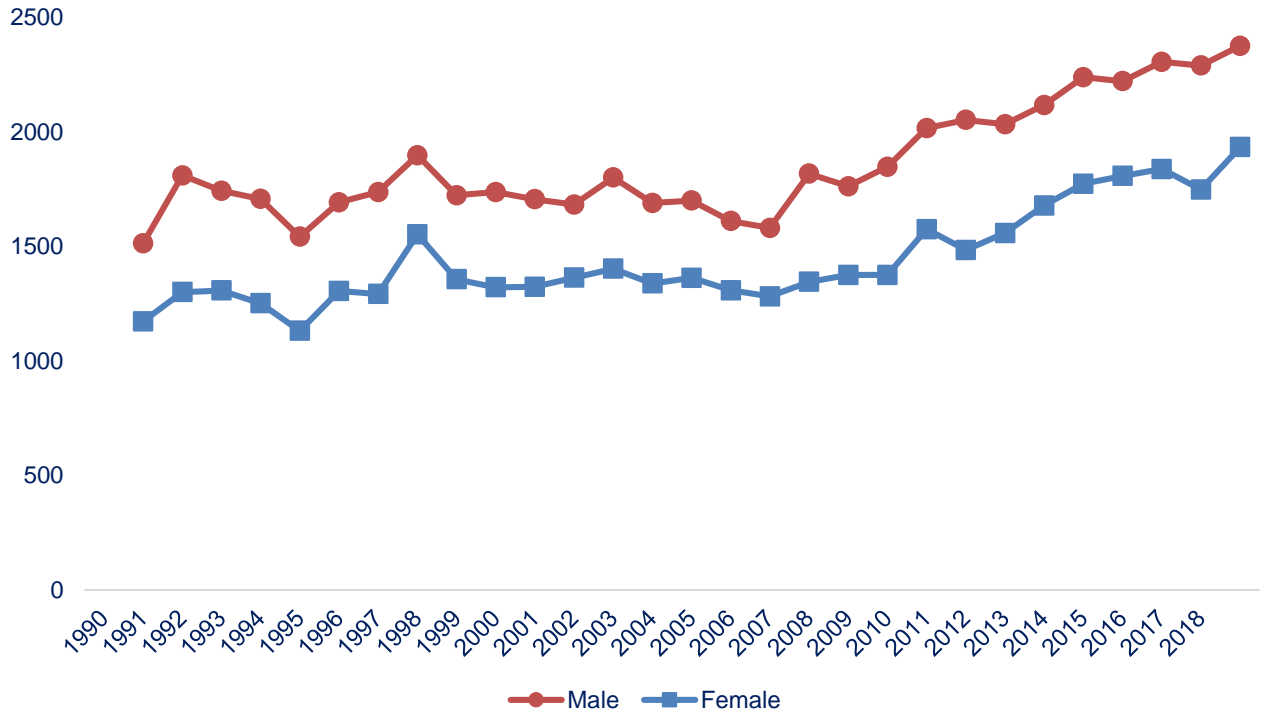

DISEASES OF THE CIRCULATORY SYSTEM



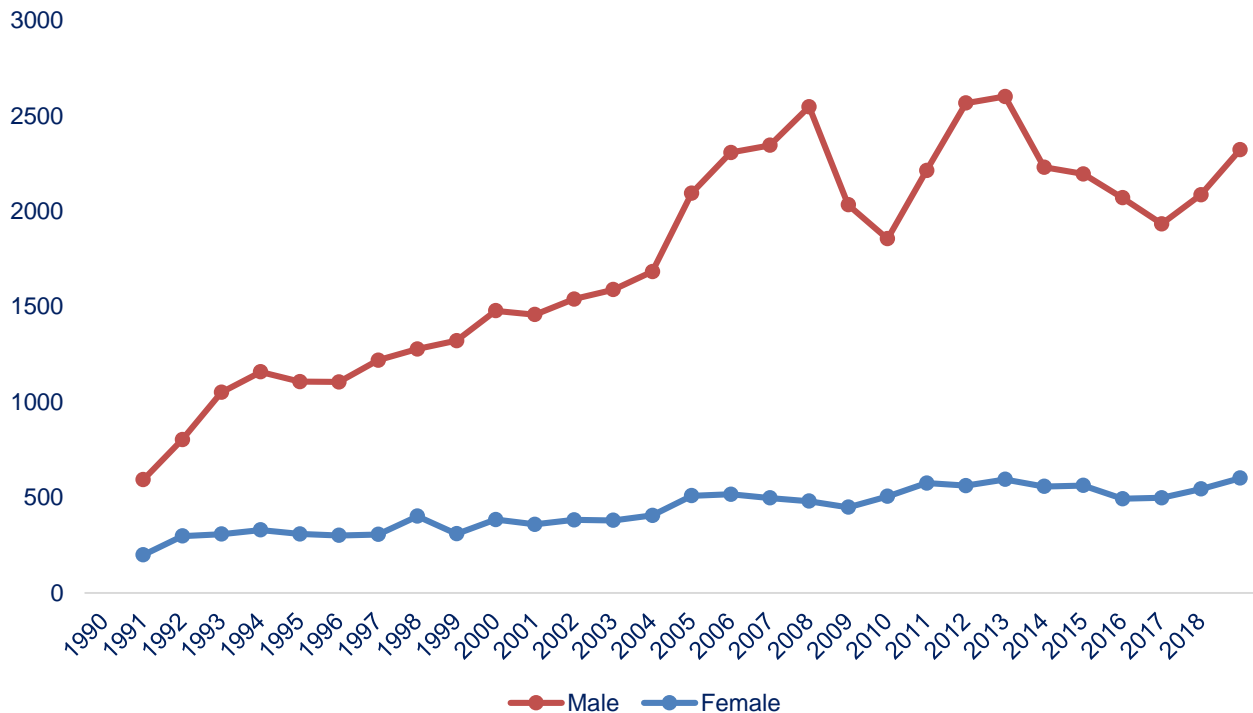
2nd cause of death in Mongolia
