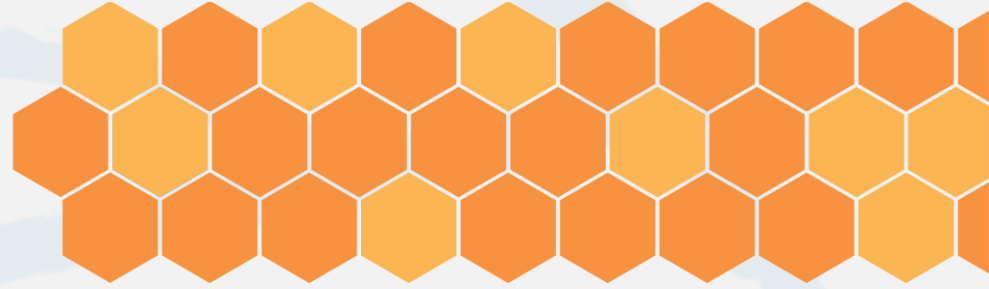

For each project, partners were required to specify: Goal(s), Action Area(s), Type(s) of Support and Implementation Step(s)

Relevant info & findings

-  Missing responses from a few important partners, such as UNICEF and WHO;
-  A total of 39 on-going projects were mapped, involving 5 partners and 16 countries;
-  There are many more projects in some countries than in others;
-  Bangladesh: 18 projects (all goals and areas affected). Malaysia: 1 project;

- Significant discrepancy can be observed amongst countries;
- While there are 18 on-going projects spread amongst 5 partners in Bangladesh, countries like Malaysia, Armenia and Kiribati there is only 1 on-going project with only 1 partner;

Goal 1 – Universal civil registration of births, deaths and other vital events;

Goal 2 – All individuals are provided with legal documentation of civil registration of births, deaths and other vital events, as necessary, to claim identity, civil status and ensuing rights;

Goal 3 – Accurate, complete and timely vital statistics (including on causes of death) are produced based on registration records and are disseminated;
