1. Regional Action Framework of Korea

Goal 1: Universal civil registration of birth, deaths and other vital events

Target 1.A. Percent of births in the territory and jurisdiction in the given year that are registered.

2014 99.9% By 2024 100.0%

Target 1.B. Percent of children under 5 years old in the territory and jurisdiction have had their birth registered.

2014 99.8% By 2024 100.0%

Target 1.C. Percent of all individuals in the territory and jurisdiction have had their birth registered.

2014 99.9% By 2024 100.0%


Target 1.D. Percent of all deaths that take place in the territory and jurisdiction in the given year are registered.

2014 99.7% By 2024 100.0%


2. Implication for a Regional Support Framework

Death Registration Completeness in KOREA






Supplementation Survey

- 1. Since 1999, Statistics Korea collected a crematory data to collect infant, fetal death and maternal mortality information not available from routine vital statistics system.
 - Infant death: death under one year of age
 - Fetal death: death of a fetus at 16 week of gestation and more
 - Maternal death: death of a women within pregnant or within 42 days of termination of pregnancy.

Reporting System



Legal Basis

ACT ON THE REGISTRATION, ETC. OF FAMILY RELATIONSHIP (Ministry of Justice)

Article 46 (Person Responsible for Filing Report)

(1) The report of <u>birth of a child</u> born within wedlock shall be filed by the father or by the mother.

Article 51 (Cases where Child Dies before Filing Report of Birth)

In cases where <u>a child dies</u> before filing the report of birth, the report of death shall be filed together with the report of birth.

Article 52 (Abandoned Children)

(1) A person who has found an <u>abandoned child</u> or a national police official who has received a notice of found abandoned child, he/she shall notify the head of the Si/Eup/Myeon concerned of the fact within twenty four hours.

Legal Basis

STATISTICS ACT (Statistics Korea)

Article 24 (Provision of Administrative Data)

If necessary for the collection of statistics, the head of a central administrative agency or the head of a local government may request the head of a public institution to provide administrative data.

Article 24-2 (Provision of Data by Judicial Agencies, etc.)

- (1) Where it is necessary for the collection of statistics, the Commissioner of the Statistics Korea may request the Minister of the National Court Administration to provide digital data on the registration of family relations.
- (2) Where it is necessary for the collection of statistics, the Commissioner of the Statistics Korea may request the Minister of Public Safety and Security, the Commissioner of the National Police Agency, etc. to provide information on criminal justice related to statistics on the causes of death.
